Chairman Ross-Raymond called meeting to order at 6:30 PM. TA Warren on vacation.

Review and Approve Minutes of last meeting

- o January 22nd, 2014 Selectman Schmidl moved to accept the summary as written, Selectman Ross-Raymond seconded. All voted in favor.
- o Review Accounts Payable & Payroll registers: Select board moved and accepted

Departments:

- Road Agent MacDuffie monthly update: Feels he has enough Salt to get through February. Ice is an issue this winter. Have worked on pot holes on Hensmith Road and repairing drop of 6 inches at South Road Bridge. Crime watch signs are up except for one. Selectman Ross-Raymond mentioned the February DOT Transportation Committee meeting cancelled but plans to go to March and will connect with Road Agent. Rte. 127 is still an issue and will be discussing with Rep Ratzki who is on the NH House Transportation Committee.

New Business:

- Petition WA received proposing \$64,000 for purpose of reinstating and funding local police department. General discussion re: amount proposed vs \$12,000 requested by BOS/Budget Committee and whether BOS recommend the article. Selectman Schmidl moved not to recommend; Selectman Ballou seconded. All voted in favor
- Selectman Ross-Raymond noted that he has been told that State Police could be asked to
 do dispatch which could be a lower cost and could mean potential of cutting down
 response time. Other towns in the state that are covered by state police.
- North Rd verbal complaint equipment operating at 1 AM. General discussion as this has been an issue in the past. Board discussed checking with town counsel re: how to proceed. Selectman Schmidl indicated he would like to speak with the individual first to see if there is an issue of major home occupation, and when work is being carried out.
- Selectmen asked AA Downes to clarify with Ed Sawyer and Steve Wheeler re: being reappointed to solid waste coop.
- General discussion re MVSD proposed budget and overall increase. This will be mentioned at the Budget committee meeting.
