Chairman Ross-Raymond called meeting to order at 6:30 PM.

• Review and Approve Minutes of the last meeting – March 18th. Selectman Ballou moved to accept the summary as written, Selectman Schmidl seconded. All voted in favor.

Review Accounts Payable & Payroll registers. Select board moved and accepted.

Committee Assignments: Selectmen all agree to keep same committee assignments as last year. Ken Ross-Raymond will continue as Ex-Officio for Budget Committee & ZBA Selectman Alternate member. Joe Schmidl will continue as Ex-Officio for Planning Board & Selectman Rep for Old Home Day Committee. Pete Ballou will continue as Selectman Rep for Recreation Committee. All other departments and committees are overseen by all of the Selectmen.

Department Updates/Issues:

Road Agent MacDuffie: unavailable for tonight's meeting.

Police log: 46 calls in March: 1 - burglar alarm; 1 - fire; 3 - hazardous operator; 1 - motor vehicle accident; 3 - request for service; 1 - sex offender registration; 1 - security check; 2 - suspicious check; 31 - traffic stops; and 2 - welfare check. Report on file in BOS office.

Rose Craven:

- SHS Flag Project: Rose Craven explained the Salisbury Historical Society will launch their flag project this spring with a target date of Memorial Day 2015 to fly our 10 flags at select utility poles in Salisbury. They will fly until Veterans Day in November and then again in the same time frame in future years. The historic flags will honor veterans in our older graveyards who took part in the American Revolution, War of 1812 and Civil War. Anyone looking for more information about the project can access it on their website. Ms. Craven's comes to the Board to get an official approval for this project. As with any signage the first step is to seek guidance and approval from the town officials. Board unanimously approves the project.
- WCP signs: Ms. Cravens also spoke in regards to the Salisbury Watch and Care Program signs and the Crime Line Signs being on the same poles. Selectmen will clarify with State but feel it better to have on one pole to alleviate too many poles along the roadside. They feel there is clear understanding that Crime line and WCP are separate.

2nd Quarter - Safety Committee Update: Completed:

- o Building Safety Issues
- Snow Removal from AH Roof
- o AH-Effective barrier put up this winter to avoid anyone getting injured by falling ice

To Be Completed:

- AH Ramp need some fill at end to bring ground put to the ramp height.
- Hazardous Mitigation Meetings will be held quarterly –May, August, November, February
- Removing damaged insulation and replacement of insulation in basement of Library. After this is accomplished get alarm system reactivated. May need another dehumidifier.
- o Put in cement slab below construction debris container.
- Inside and Outside stairways at Safety Bldg. Ross-Raymond is checking with Barnstore re: heavy duty stairway for inside.
- Town Hall Ramp access Ross-Raymond spoke with Bill MacDuffie about using granite slab or concrete at the end of the ramp. Ross-Raymond will check with Swenson Granite for costs. Perhaps could use seconds.

- Right to Know Workshop: Board approved the date of June 11th and TA Warren will schedule this with NH Municipal Association and will get memos out to town officials and committees urging them to attend.
- Purchasing Policy: Selectman Ballou has reviewed the SOP re: Expenditure of Budget Appropriations and would like it to clearly state that "a copy of the purchase order should be attached to the invoice so that the person signing the check register can verify anything in question before signing the register." Selectmen asked AA Downes to update the SOP with suggested wording.

Selectman Ballou moved to adjourn at 7:20 PM; Selectman Schmidl seconded. All voted in favor.
