

Selectmen's Meeting Summary April 2nd, 2014

Chairman Ross-Raymond called meeting to order at 6:30 PM. Selectman Ballou chaired the meeting tonight.

Review and Approve Minutes of last meeting

- Review and Approve Minutes of last meeting
 - o March 19th, 2014 Selectman Schmidl moved to accept the summary with edit, Selectman Ross-Raymond seconded. All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted

Departments:

- Road Agent MacDuffie monthly update: Doing some grading on gravel roads; Winter budget is pretty well shot.
 Selectman Schmidl asked about paving cost and maintaining as paved road vs gravel roads?
 - MacDuffie feels it would cheaper to maintain it but everyone has a different opinion. It would costly to initiatively pave a road such as Hensmith. Selectman Ballou suggests making this a possible CIP project.

2nd Quarter - Safety Committee Update:

- o Building Safety Issues
 - o Ballou and Ross-Raymond reported the Renovations at Town Hall are underway and looking good.
 - o There is a water pipe leak at the Safety Building AA Downes will contact plumber to get it fixed.
 - O John Herbert attended a Dept of Labor training where "safe workplace" was discussed. One of the issues discussed is violence from someone outside the workplace and their suggestion was to contact insurance company (Primex) to have safety inspectors' visit and make recommendations on how to improve safety and security in the office. As we are a small office and sometimes staff is alone in the open office, it would seem appropriate to request this especially since it is free. Selectmen will ask TA Warren to follow up on this.

- Wasps are coming out again upstairs Academy Hall TA Warren has bombed it once but it needs to be done again. Selectman Ross-Raymond will get bombs and do the attic area.
- o Selectman Schmidl asked about the panic buttons. They are available in each office area.
