Chairman Ballou called meeting to order at 5:30 PM. He announced he is stepping down as chair for the Selectmen for personal / health issues. Selectman Tucker nominated Ken Ross-Raymond, Selectman Ballou seconded. Selectman Ross-Raymond said he accepts the nomination. Vote was in favor.

Ross-Raymond stepped in as chairperson.

- Review and Approve Minutes of last meeting
 - April 20, 2016 meeting summaries: Selectman Ballou moved to accept both public and non-public summaries as written, Selectman Tucker seconded. All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted.
- Selectman Ross-Raymond noted that Margaret and Kathie put together an information notebook for each selectman. He thanked them for their time and effort in preparing this tool for them. He noted that in the book are the town's SOP's. These policies are not required by law but are put into place as safeguards and tools for all town officials.

Departments:

Road Agent MacDuffie – monthly update

- Patched some holes in pavement and some grading
- Roads are no longer posted short mud season.

Transfer Station – Survey results: Seventy-one surveys were completed. Results showed 63 in favor of having additional hours another day of the week. There were 8 people who either did not feel another day is necessary, or would like to see the transfer station opened earlier on Saturdays. Also couple suggested other days – Friday and Sunday.

Board feels it is time to move forward with a test pilot for additional hours and will go with the suggested day and time from Transfer Station staff. TS Operator Wheeler will be contacted to see when they will begin with additional hours each week on Wednesdays from 2 PM - 6 PM and will have these extra hours for 3 months and then review to see if they will continue with this change.

New Business:

- Recommendation for Appointment of Sexton. Cemetery Trustees accepted resignation from Mel Bowne as trustee. Mel has submitted letter of interest to fill the sexton position and Trustees recommend Selectmen appoint him. Selectman Ballou moved to accept their recommendation and appoint Melvin Bowne to the Sexton position, Selectman Tucker seconded. All voted in favor.
- Polling Hours 2016 State Primary and General Election: Question was raised re: what the polling hours will be for the 2016 State Primary and General Election. In checking with the Secretary of State the town cannot change time it has been following without town meeting vote. Checking records show for State and General elections the polls are open from 8 AM 7 PM. Board unanimously agreed to keep the polling hours as 8 AM 7 PM. The controversy at town election this year was hours had to be 11 AM 7 PM per decision of attorney general. Board unanimously agreed to keep these hours for town meeting polling hours.
- Selectman Ross-Raymond noted now is the time to pick a date for Town roads road side clean up. AA Downes will check to see when Explorers will be doing their spring road side clean up for Route 4.
- Selectman Ross-Raymond asked AA Downes to work with TA Warren and office staff to set up a staff meeting in the near future.
