

Selectmen's Meeting Summary October 5th, 2016

Selectman Ballou called meeting to order at 5:30 PM. Selectman Ross-Raymond unable to attend tonight due to work out of state.

- Review and Approve Minutes 9/21/16 meeting. Selectman Tucker moved to accept the September 21st meeting summary as written, Selectman Ballou seconded. Meeting summary approved.
- o Review Accounts Payable & Payroll registers. Select board moved and accepted.

Department Updates/Issues:

Road Agent MacDuffie – Monthly Update:

- Spraying of Bamboo has been done. This is the second year this process has been done.
- Cracks in Pavement on Raccoon Hill Rd and West Salisbury Road have been sealed.
- Signs for school received and will be put up

Selectman Ballou noted he has been traveling Warner Road couple times a week and appreciates the good condition of the road and thanked MacDuffie for his hard work.

Nancy Hayden, OHD Chair – 2016 Wrap Up issues. Looks like we have \$359.20 unspent and would like to encumber for 2017 fire works. Selectman Ballou moved to encumber the remaining \$359. to be put towards cost of 2017 fireworks, Selectman Tucker seconded. Motion accepted. Nancy gave TA Warren the 2017 contract for fireworks with Atlas.

- TA Warren contacted Ron Taylor, State Police re: concerns of some residents on Whittemore Rd. He indicated he would look into getting a radar trailer, not in favor of speed bumps, and will work with town re: special detail patrols. He did note that in looking back at their logs in the past two years only two calls were received relating to Whittemore Road. He did stress people need to call with their concerns and/or complaints.

New Business:

- Emergency Operations Plan dated 2010 needs to be updated to allow us to apply for grants and FEMA have been contacted. To update the plan we can contract it out (Jane Hubbard did it last time) or Fire Chief can review with his department and document update which would be enough for Homelands Security to accept. Fire Chief MacDuffie has opted for his department reviewing and TA Warren has prepared and sent letter on behalf of the town to FEMA for September 2017 extension.
- Selectman Ballou noted perhaps one of the grants we could look at is a water filtration system at Safety building.
- With the lack of rain we have had some inquiries about availably of water from town buildings. Outside faucet at Safety Bldg is available for emergency use in moderation however water is not drinkable.
- TA Warren noted the Fire Chief reported the Tahoe did not pass inspection due to rust issue and he is hoping to get fixed out of this year's budget.
- 2016 NHMA Conference is Nov 16th an 17th at the Radisson Hotel in Manchester. Conference is open to NHMA Members (town employees). April has signed up for the Wednesday session for ADU's..
