## Department Head Budget Reviews

The Committee reviewed the budgets as presented for the following departments:

## 4155 Personnel Administration \$31,934

Brett Walker motioned that they accept the budget for Personnel Administration as presented at \$31,934.

#### 4215 Ambulance \$128,392

Brett Walker **motioned** that they accept the Ambulance budget as presented at \$128.392

**Kevin O'Neill** noted that the cost for this seems like it is increasing each year. **Bill MacDuffie Jr.** said that the \$100K is a lot, but it's better than they will get elsewhere at the moment. It's based on population and their population is steadily increasing. **Eric Swendsen** asked about how many ambulance calls they have per year. **TA Rollins** estimated that it is somewhere around 120.
