New Business - Member Michael Rossetti spoke about a fungus that he has in his yard called Artillery Fungus. It is a mushroom fungus that can shoot its fungus 20 feet. It is usually found on wet mulch. It will leave spots on your home and cars and is difficult to remove.

Members Bill and Sarah MacDuffie have announced their intent to step down off the Conservation Committee Board in November 2023.
