Review of ZBA Alternate Applicant

The Zoning Board reviewed the request and qualifications of Eric Maxwell, who applied to become an alternate on the Board.

Vice-Chair Kelly **motioned** that they accept Eric Maxwell as an alternate member. Loretta Razin **seconded** the motion for discussion:

**Eric Maxwell** told the Board that he recently moved to Salisbury and he has a desire to become more intimately involved in his town and to meet people. He has moved a lot and lived in large cities. Prior to living in Ireland, he lived in Los Angeles and other areas on the West Coast. Now that he is a resident, he has an interest to contribute in ways he hasn't been able to in the past.

**Chair Bentley** asked how long he's lived in town, wondering about residency requirements. **Eric Maxwell** said that he has lived here for almost two weeks, adding that he did speak to Town Administrator Rollins who had suggested that he approach the Zoning Board as an alternate as a way to get started. **Chair Bentley** said they can follow up with April on this just to be sure.
