

Selectmen's Meeting Summary November 1, 2017

Chairman Ross-Raymond called meeting to order at 5:30 PM.

- Review and Approve Minutes of 10/18th Meeting. Selectman Ballou moved to accept the October 18th meeting summary, Selectman Schmidl seconded. All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted.

Departments:

- Fire Chief MacDuffie Monthly Update:
 - Stats: October was busy. 12 EMS calls, 3 service calls (pumped basement, lift assist, start generator), 1 mutual aid fire, 1 outside fire
 - Hayride was great- over 500 wait was not bad. Sandy Miller asked how much they make. *Profit of \$1200*.
 - EMS has been busy had seven calls Monday
 - Ken Ross-Raymond noted Paul Martin indicated he could do another Flu Clinic in November? Chief said Mr. Martin spoke about doing it annually – but he has no problem if they want to do it again in November. Five came that Saturday. Ross-Raymond to follow up.
 - Fire Pond at corner of Oak Hill and Raccoon Hill Roads is full –Chief will have Franklin inspect the hydrant. Selectmen suggest sending a letter to contractor who did a great job. Chief will get name and address for TA Warren to do a letter.
- Road Agent MacDuffie Monthly Update:
 - North Road should be paved tomorrow.
 - Monday's Storm Most all roads affected nothing drastic Trees for most part. Eversource did call to ask if they needed to do anything. Asphund tree crews went out to check as well. To Chief's knowledge North Rd, Raccoon Hill Rd, New Road and Couchtown Rd still without electricity. Some roads under water for short time.
 - He called Dingee to move forward- no firm date for completion.
 - Selectmen reminded him need stop sign End of Rabbit Road Ext & Warner Rd. Chief will check all roads before ordering signs.
