- o Review and Approve Minutes of 12/20/17 Meeting. Selectman Ballou moved to accept the December 20<sup>th</sup> meeting summary, Selectman Schmidl seconded. All voted in favor.

#### **Departments:**

# 1st Quarter - Safety Committee Update:

- Frozen Pipes at Town Hall –(has been fixed) discussed having the flashing of light re: low temperature be a colored light.
- Discussed Wifi at town hall it is needed ocassically and we can use from library.
- Sub Zero weather transfer station small heater / insulation for building. Need to look at upgrading what it presently there.

### **Fire Chief MacDuffie** – monthly update:

- 1 Wires, 3 EMS, 2 Mutual Aid Fires, 1 MV Accident AND 1 Fire Alarm
- Ended 2017 with 153 calls.
- Workiing on grants
- Digee ready to move along Selectman Ross-Raymond was impressed with his operation.
- All vehicles are good for another year done by Patsy's.

#### Road Agent MacDuffie – monthly update

- Plugging away as we get storms
- Need to look at rate increases for contractors when doing 2018 budget.
- Also need to review equipment needs for future.

  - Maplewood Cemetery Rd \$800 to do road work. Selectmen Ballou moved to encumber \$800 for continued road work; Selectman Schmidl seconded. All voted in favor.

- OHD 2017 unspent \$581. Selectmen Ross-Raymond moved to encumber \$581 to go towards 2018 fireworks display; Selectman Schmidl seconded. All voted in favor.
- Transfer Station Overhead Door \$3,700. Selectmen Ballou moved to encumber
   \$3700 for installation of overhead door at Transfer Station; Selectman Schmidl seconded. All voted in favor.

  primary. Town Administrator will check with Bill Couglin re: interest in serving; and if he is
  not available Selectman Ross-Raymond offered to be alternate. Selectman Schmidl moved
  to go with Bill as first choice and Selectmen as second choice; Selectman Ballou
  seconded.
- Bond Policy any loans going forward \$25,000 bond be required. TA Warren to review with town counsel on how to approach this issue.
