

## Selectmen's Meeting Summary March 6<sup>th</sup>, 2018

- Review and Approve Minutes of last meeting
  - February 21<sup>st</sup> Selectman Ballou moved to accept the 2/21/18 meeting summary; Selectman Schmidl seconded. All voted in favor.
- o Review Accounts Payable & Payroll registers. Select board moved and accepted.

#### **Departments:**

 John Herbert – Moderator – Town Meeting Election Discussion: General discussion re new voter registration process. Moderator noted most warrant articles are self-explanatory, WA 7 – Maplewood Recreation area – grant: Will ask Kathleen Doyle to be ready to speak on this issue. WA 13 – Ambulance Revolving Fund – Chief MacDuffie to be ready to speak re questions. May need to look at amending the article re fees – TA Warren to get information on this before town meeting.; WA 14 – All Veterans Tax Credit – TA Warren to speak to any issues. OHD/Fireworks Committee will do meals for town officials. TA Warren will hopefully have the fund balance from auditors by town meeting.

Selectmen discussed having a representative from DRA at the meeting to clarify the problem concerning \$79,100 inadvertently being added during our processing the preliminary tax rate. Visitors at meeting think that it is a good idea to have someone present. Board agreed to confirm with Bruce Kneuer from DRA to be at the business meeting.

## • Road Agent MacDuffie – monthly update:

- All the dirt roads are in rough shape. Grading as necessary
- Logging operations are being looked at to ensure not to jeopardize roads and posting roads as necessary.
- Plows are ready for ensuing storm.

## • Fire Chief MacDuffie – monthly update:

- Stats: 5 ems; 1 car fire, 1 fire alarm
- Chief still working with Penacook re: cost for doing transports for Salisbury.
- Selectman Schmidl suggest having work session after town meeting to come up with workable solution.
- Chief asked TA Warren if we could put info on website about Auxiliary.
- Chief hopes to have update re: progress on new vehicle from Dingee by town meeting

## **Old Business**:

- Review of RFP bids for Assessors: Selectman Schmidl prepared spreadsheet and they reviewed the totals:
  - o Avitar \$99,200
  - CCAG \$83,350

Comparable coverage: Discussion of difference in costs/companies. Selectmen leaning towards Cross Country and requested TA Warren to ask Jeff Earls in to next meeting for some clarification questions before making final decision.

- Update re: Consolidated Communications Inc: Selectman Schmidl still working to get clarification from CCI for the 33 users in the North Road area.
- Meeting Updates
  - Cemetery Trustees met 3/1 discussed buying back unused cemetery plots; worked on drafting job specs for sexton position; Maplewood cemetery wall recently inspected by Sexton and revealed several cracks.
  - Planning met 3/5 met with CC re: agricultural zone; discussion of voluntary merger of lots on Franklin Rd, and having farmers come to meeting to discuss their views re agricultural zone.

- Projects Need to follow up regarding request to paint safety bldg interior and town hall project by Ralf Platte.

## New Business:

- Abatements 3 utilities; 8 others. Jeff Earls letter explains likely utility issue. Abatements on internet issue do we take decision of assessor. Two applied for abatement due to poor internet service. TA Warren explained Earls has given an economic depreciation at person's request if house doesn't have high speed internet.
- Police Reports Selectman Ross-Raymond talked about Website vs. other social media chatter on Facebook that may be causing unnecessary alarm. He proposes putting the monthly stats for police calls on website.
- Map for Maplewood Recreation area which was prepared at no cost by surveyor Stout at request of Recreation Committee for grant proposal was reviewed. Town counsel recommends town record the map and send a letter of thanks to Stout. Selectman Ballou made motion to get mylar signed and recorded and to do letter of thanks to Stout; Selectman Schmidl seconded. All voted in favor.

- Selectman Ross-Raymond visited with MVSD Superintendent to go over numbers to get feel on how their budget will affect our taxes. Due to drop in students our commitment will be less.
- RFP notices local businesses: Selectman Ross-Raymond had been contacted by local contractor about doing better job in letting local business know when we have RFP. Need to put out invitation to local contractors to leave business card, etc. Also noted that Peter Mason brought up having a booth at OHD re: how many small businesses in Salisbury and to recognize them.
- TA Warren reminded Selectmen of the AED Training on March 29<sup>th</sup> at Town Hall between Noon and 3 PM. They need to sign up with Gayle Landry.
