Department Updates:

• Gail Henry – 250th Committee Final Report: We had a lot of events and all were great and most well attended. There was only \$1 in budget line item and committee had several fund raisers. - Meeting Updates
 - Budget met 12/10/18 getting close to end
 - Selectman Schmidl attended the Watershed meeting 12/12/18. FEMA is revising the watershed maps which are 20 years old. Copy of map is upstairs with the Planning Board and Chief MacDuffie and anyone who has info to add should review it. We need to get info back to FEMA by mid-January.
 - Selectman Ballou attended the joint Salisbury/Webster Elementary Schools DARE graduation on 12/12/18. Deputy Fiske put on a very good program for the 5th grade graduates. Great program the town sponsors.
 - Selectman Schmidl attended the Recycling meeting on 12/13. Four people attended and this core group foster recycling and talked about options. Newsletters will be forthcoming and meeting minutes will be posted on town website. Group meets the 2nd Thursday of each month.

- MVSD Collaborative Mtg Request 1/10/19 All selectmen going.
- Mutton Road: Inquiry from resident re: road being blocked off. Class VI road grade stakes put up across the road by landowner because road is washed out and not passable.
- TA Warren got quote from Huckleberry for replacement heater (present one is 25 years old) for entryway at Academy Hall of \$2,000 for installation and removal of old one. **Selectmen moved and approved to have heater installed.**
