Selectman Schmidl opened the meeting at 5:30 PM. Selectman Schmidl started the meeting with a moment of silence for Melvin Bowne, Sexton and Supervisor of the Checklist who passed away this week.

- Reviewed and Approved Minutes of January 16, 2019. Selectman Schmidl moved to accept the January 16, 2019 meeting summary. Selectman Ballou seconded. All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted.

Departments:

Fire Chief MacDuffie – Monthly Update

- Stats: 2 Service calls; 1 M/V Accident call; 1 Mutual Aid Fire calls; 2 Fire calls; 6 EMS calls
- Chief MacDuffie noted the soonest they may hear from Franklin Fire Chief regarding mutual aid could be in July. He mentioned we'll need to talk with Lakes Region Dispatch and will set up a time to go over details with them. Discussion with BOS regarding ambulance coverage with Penacook Rescue waiting for Penacook to come up with an agreement. Topic on hold until after Town Meeting in March.

Road Agent MacDuffie – Monthly Update

• Noted if we have any more unseasonably warm days they may need to post load limit signs.

 - Trustees of the Trust Fund End of Year Update Steve Wheeler did not attend since he had nothing new to report.

Old Business:

- TA Warren noted a claim has been filed with Primex for the damage to the loader waiting for a quote from Beauregard Equipment. Selectman Ross-Raymond had received an invoice close to \$3,000.00 to fix it. Selectman Ballou noted it would be between \$3,000.00 \$4,000.00 to cover repair costs and rental charges.
- **Final Review of Proposed 2019 Budget Figures and Warrant Articles -** TA Warren reported there were no changes with the Warrant Articles. The difference of \$1,000.00 due to decrease in the VNA brought the BOS original figure of \$1,282,194.00 down to \$1,281,194.00. TA Warren noted the VNA local representative will be coming to the Budget Hearing to talk about this.
- **Review Revenue Sheet:** Reviewed Revenue Sheets before they go to the Budget Committee. Last years' Total Revenue was \$701,122.00 and this years' is \$597,745.00.

- Champagne Excavation Project approved by Andover ZBA. Selectman Schmidl suggested the SPB write a letter to APB noting approval would need signatures from both towns, since the plan depicts part of Salisbury and abuts the Salisbury town line. At the last SPB meeting they decided there was not enough regional impact to write a letter. Selectman Schmidl reviewed the RSA noting he will follow up with that letter with the SPB since both towns should sign off on it
- Comstar Ambulance Billing Service rate changes for 2019 TA Warren noted they raised rates and suggested an average bundle rate. Fire Chief MacDuffie will be obtaining a list of Penacook Rescue rates in the next two weeks. Selectmen will review this when available.
