Regular Business:

- Review and Approve summary minutes of February 6, 2019 Selectman Ballou moved to accept the February 6, 2019 meeting summary with corrections. Selectman Schmidl seconded. All voted in favor.

- Meeting Updates:
 - 2/11 Budget Committee Meeting and Public Hearing for Proposed 2019 Town Budget TA Warren noted everything has been finalized, submitted, and posted.
 - 2/13 OHD Committee Selectman Schmidl attended along with twelve others. The theme for OHD this year will be Farm Days. Plans to substitute the classic car evening with tractors and end Saturday night with a dance. TA Warren noted Tommy the Train will be part of the festivities and the deposit has already been processed.
 - 2/14 Recycling Committee Selectman Schmidl noted the committee finalized their mission statement. Their goal is to make presentations at schools for recycling, reducing, and reusing items. They will be placing display boards at the Transfer Station on rain barrels, composting bins, and so on. People could sign up for any of those items and would be contacted later to prepay for these items. Their goal is to get residents to commit financially.
 - Speed Limit 2nd Request Route 4 through Hensmith Road and Whittemore Road Selectman Ballou noted other signs to post on Route 127 such as; "No Thru Traffic". TA Warren noted RSA 41:11 Traffic Control Ordinances would need to be addressed and brought before the public.

 - Andover ZBA Special Exception The SBOS and SZBA have written letters to ABOS and AZBA regarding RSA 36:54-55 requesting a rehearing on the Champagne Special Exception permit approval due to regional impact and town line boundary.
