Chairman Ross-Raymond called meeting to order at 6:30 PM.

Review and Approve Minutes November 19th, 2014 meeting: **Selectman Schmidl moved to accept summaries as written, Selectman Ballou seconded. All voted in favor.**

Departments:

- Road Agent MacDuffie Monthly Update:
 - o Busy with recent snow storms.
 - o Followed up on Selectmen inquiry re: cost of taking care of ledge at Little Hill and Couchtown estimate of \$6000 to blast and discard.
 - 2014 Culvert Project budgeted \$18,000 had to use portion for replacement of culverts in other areas but still have enough left for original area. Question is whether we need to encumber this money for project to be completed next year. Will clarify with TA Warren.

New Business:

- Email from Bruce Johnson, Webster Selectman asking board to entertain a warrant article (resolution) for the 2015 town meeting. "Resolved that the State of NH provide a comprehensive meaningful system of funding for State Education needs. To see if the Town will vote to ask governor and our state legislators to reform state funding for education with that reform to be directed to significant reduction of property taxes. The record of the vote approving this article shall be transmitted by written notice from the Select Board to the governor and state legislators informing them of the instructions from their constituents within 30 days of the vote." The board unanimously agreed to put this on 2015 town warrant.
- Selectman Schmidl inquired re: deadline for petition warrant articles as he is looking into having one re: tax exemptions for energy saving such as solar panels.
- Question re: Selectmen salary and when last increase occurred. Selectman Ballou to check what is budgeted in surrounding towns.
- Selectman Ross-Raymond noted that town of Webster had State Emergency Services do a telephone message to town residents re: emergency warming station. Salisbury Fire Department had also set up Safety Building for those who needed a place to stay. Selectmen agreed to follow up with Chief MacDuffie and Webster Selectman Fanjoy re: adding Salisbury to such message as needed. Selectmen also discussed the need to have portable water at the Safety Building and Selectman Schmidl to follow up on this issue. Sandy Miller from North Road noted that the SVFRD came out to check on her and other town citizens who were without electricity for extended periods.

• Walter Scott – In to speak with Selectmen re: front entrance at Academy Hall – putting up sign to use ramp entrance during winter to avoid falling ice. Also noted he spoke with town custodian re: use of ice melt instead of sand to avoid dirt being tracked into buildings. Selectmen noted bottom line is safety – and to use judgment re: use of sand/salt and ice melt.

Public Comments:

Sandy Miller: Asked why on budget report it does not reflect recommended by BOS as it has in the past. *Not sure will look follow up with TA Warren and Bookkeeper.*
