Chairman Ross-Raymond called meeting to order at 6:30 PM.

Road Agent MacDuffie: To follow up on questions asked at the Budget Committee meeting last week, he came in to give an update on the 2015 Winter Highway budget. As of this date, he has spent \$78,402 of the \$122,800 appropriated. Board noted they would like him to be prepared at Town Meeting to discuss the balance at that time.

- Town Report Update Kathie reported she took the final proof to the printer yesterday. She was notified this afternoon it is all printed and can be picked up at the Warner office. She also will be getting the file electronically and will have it put on the website.
- Handicap Lift Academy Hall: Selectman Ross-Raymond spoke with NE Lift Co. about increasing the speed of the lift and they advised this is not possible. The door issue (heavy and difficult for handicapped to open) could be remedied with an automatic door opener installed but that is very costly and probably not cost effective with the amount of usage of the lift.

■ Town Building – Roofs: Selectmen concerned with all the snow this season and roofs of our town buildings. Selectman Ballou reported he looked at town hall and library and they appear to be okay. Academy Hall roof does appear to need snow removed. Selectboard all agree this needs to be accomplished. TA Warren will take can of finding a contractor to do this.

Board discussed the new rate for heating oil for next year (through school district bid process). Huckleberry bid is \$2.24.8. Selectman Ballou moved to lock in with Huckleberry, Selectman Schmidl seconded. All voted in favor.
