Chairman Ross-Raymond called meeting to order at 5:30 PM.

REGULAR BUSINESS:

- Review and Approve Minutes of last meeting
 - o October 7th meeting summary: **Selectman Schmidl moved to accept summary as written, Selectman Ballou seconded.** All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted

Jim Sperry: Salisbury resident from Oak Hill Road in to discuss selling hot dogs on snowmobile trail on his property this winter. He has a hot dog cart and a state license to sell. Board not sure if he is looking at a home occupation – so referred him to ZBA. Building Inspector/Health Inspector noted he has a state license so he does not get involved. April Rollins, ZBA secretary will follow up and contact Mr. Sperry. Sandy Miller noted she feels Snowmobile Club would like to see something like this during the snowmobile season. Selectmen also feel it is a reasonable request.

Department Updates and Budget Proposals:

- Fire Chief Monthly Update:
 - o Stats: 3 ems; 2 wires down, & 1 mutual brush
- Comcast minor update starting (prior to starting certificate of insurance) 120 days up and running. January 1st
- Haunted Hay Ride Saturday asked about electricity at field
- Fire Tanker Bid Opened one bid from Valley Transport \$261,928.

2016 Budget Schedule: Board of Selectmen noted that they will hear and entertain all proposed budgets – with a hold on finalizing salary line items until all budgets are heard.

Recreation, Chairman Doyle	Recreation has seen more activity at Maplewood field this Summer - more
	games, fall soccer practice and special events throughout the year. Plans to
	purchase a small rototiller to maintain baselines. Would like to see the
	electricity and restroom to remain all year. Increase in electricity and
	sanitation line items. Keep maintenance and general expenses line items
	same. Plans to replace ice rink liner and enlarge rink with 2016 budget.
	2016 budget proposed at \$3,125.
	Doyle requested permission to order sand for infield this year from 2015
	maintenance line item – and MacDuffie Construction has agreed to truck at
	no cost.
Town Clerk – registrations & vital stats	Selectman Ross-Raymond reported Town Clerk Rollins unable to make
	tonight's meeting but had emailed wants to keep budget same as 2015
	except for request to increase the deputy salary to be put back up to 1,300
	as was in 2014. TA Warren noted it was reduced as new deputy did not
	have years of experience as previous one. Board went with town clerk
	recommendation of keeping same as 2015 – but restore stipend for deputy
	to \$1300. 2016 proposed figures are \$19,938.
Fin Adm – Tax Collector – Gayle	Recommends same as 2015 with increase in salary – 2016 proposed figure
Landry	is \$19,890.
	She also reported the last bill for 2015 taxes will be sent out this week –
	with taxes due December 2 nd .
Conservation – Chair Doyle	Same as 2015 – 2016 proposed figure \$500.

Fire/Rescue/Forestry – Chief MacDuffie	Ambulance bottom line is proposed up by \$1,150. Increase in outside
	ambulance service and dispatch and small decrease in training. Total 2016
	proposed figure is \$25,700.
	Fire Department bottom line is proposed down by \$12,050. Dispatch & air
	pack maintenance increased, but replacement equipment is down and
	nothing budgeted for foam and air pack lease purchase. Total 2016
	proposed figure is \$33,950.
	Forest Fire bottom line is proposed up by \$650. Dispatch and new
	equipment both increased. Will be applying for grant for ½ cost of new
	equipment. Total 2016 proposed figure is \$8,400.
	Total bottom line for fire/ambulance/forestry for 2016 is \$68,050 – down
	from 2015 by \$10,250.

- Perambulations Franklin has expressed interest in doing soon. Selectman Schmidl will schedule time.
- Transfer Station follow-up:
 - o Enclosure for backhoe salt shed best and least expensive to fix Ken to look at cost of overhead doors and supplies. Needs to get done sooner than later.
 - Backhoe problem with starting needs to be plugged in. While it is housed at Ross-Raymond's he will plug it in Friday night. Also need to be prepared if have tire problems have a tire road crew number that can be called. Bill MacDuffie, Jr. suggests having a spare wheel for a used tire which he could supply.
 - o Housing for employees needs to be addressed it has been proposed finding a used camper with furnace.
- Town Hall Ramp End of ramp has a dip that needs to be repaired before winter. Selectmen Ross-Raymond and Schimdl to take care of this soon.
- Library follow up re Enviro Vantage quote Board feels no health issues at this time so will table until spring. Selectman Schmidl also feels we can ask explorers to to remove insulation.
- Ordinance Franklin and Durham: Selectmen have reviewed State Police recommend following Franklin Ordinance. Administrative Staff will work up a draft ordinance for Salisbury to be used for a public hearing and ask State Police to come to speak on the issue at the hearing. This will determine if Selectmen want to bring the subject to town meeting in March 2016.
- Selectman Ross-Raymond noted that Salisbury has been covered by State Police for the past five year and will begin the sixth year in November.

New Business:

- 2015 tax rate Board agreed to use \$130,000 from general fund to bring rate in at \$24.23 versus the \$25.22 rate without offsetting with surplus.
- Presidential Primary has been tentatively set for $\frac{2}{9}/16$ at Town Hall from 8 AM 7 PM.
- Workplace Violence Training SOP in place and Selectmen has asked Property Liability Trust to provide a training session for employees and town officials on Nov 30th at Town Hall beginning at 6:30 PM 7:30PM. Other towns will be invited to participate.
