Chairman Ross-Raymond called meeting to order at 5:30 PM. He welcomed State Representatives Ratski and Karrick to the meeting tonight.

REGULAR BUSINESS:

- Review and Approve Minutes of last meeting
 - o December 2, 2015 meeting summary: **Selectman Ballou moved to accept summary as written, Selectman Schmidl seconded.** All voted in favor.
- Review Accounts Payable & Payroll registers. Select board moved and accepted

Department Updates:

- Police Monthly Update: November 2015 total calls 27: 1 911 hang up; 1 ambulance need; 1 assault in progress; 1 assault past tense; 1 civil request; 1 criminal mischief; 1 domestic past tense; 1 hazardous operator; 4 motor vehicle accident; 4 request for service; 1 suspicious person; 7 traffic stops; & 3 welfare check.

Old Business:

- Draft Disorderly Residence Ordinance final review by BOS. Will present with some highlighted areas for discussion at the public hearing which will be held on January 20th and TA Warren will notify State Police to have them present for that hearing for questions.
- Perambulation Franklin Ross-Raymond reported it is half complete and hopefully will be finished this week and he will do the report upon completion.
- Holiday Baskets pickup Dec 22nd in Boscawen and we will distribute to town recipients who have applied for them from Salisbury Safety Building at 9 AM.
- Meeting Updates
 - O Planning Board met 12/7 and 12/12: 12/7 meeting held Public hearing for 12-lot Major Subdivision. Additional site walk scheduled for 12/12. Public hearing continued to January 4th meeting. Master Plan's community survey has been sent out to test group. 12/12 site was has held and will be discussed at the 1/4/16 continued public hearing.
 - Budget met 12/14: Steve Wheeler resigned due to state RSA.
 Vacant position posted for temporary filling until March town meeting.

New Business:

- Pistol Permits: State Police might be able to take on doing the background checks at no cost to the town. Application fee of \$10 would stay with the town. Currently Merrimack Country Sheriff's Dept handles them charging the town for the background check and keeping the \$10 application fee.
- Transfer Station: Several individuals have inquired about having the transfer station open a second day each week. Selectmen are looking for input from the general public.
- Generator transfer station Ross-Raymond asked TS Operator Wheeler to give BOS recommendation on what should be purchased.
- Ross-Raymond noted that after the recent seminar re: workplace violence the Selectmen
 discussed seeking help from the PLT re: how best to secure our buildings and offices.
 Selectman Schmidl moved to contact company with the request; Selectman Ballou
 seconded. All voted in favor.

Public Comments:

• **Kathleen Doyle - Recreation:** As discussed with BOS previously she has found a Tiller for ball field and will purchase before year end.

State Representative Mario Ratski - Noted he had some information about broadband for areas in town that presently do not have it. Fairpoint has some grant money from FCC to better set up broadband. Selectman Schmidl will touch base with North Road residents to get a committee together to follow up on this issue.

Board of Selectmen thanked both Rep Ratski and Rep Karrick for sharing this special meeting tonight. Board noted their appreciation on behalf of the town for all the representatives have done for the town in 2015. Also thanked State Police for stopping by.
