Chair Hood called the meeting to order at 7:00 p.m.

OLD BUSINESS

Approve Minutes

Chair Hood **motioned** to accept the draft meeting minutes of October 18, 2021 as written. David Kelly **seconded** the motion which passed unanimously.

AGENDA ITEMS

Budget Meetings with Department Heads

4220 – Fire Department –\$39,341

No discussion or questions asked.

Chair Hood **motioned** to approve the Fire Department budget at \$39,341.00. Selectman Walker **seconded** the motion and it passed unanimously.

4215 – Ambulance – \$103,290

TA Rollins noted that this may increase.

Chair Hood **motioned** to approve the Ambulance Budget at \$103,290.00. Dave Merwin **seconded** the motion which passed unanimously.

4290 - Forestry- \$9,140

No discussion or questions asked.

Chair Hood **motioned** to approve the Forestry Budget at \$9,140.00. David Kelly **seconded** the motion which passed unanimously.

4312 – Highways and Streets Maintenance – \$350,322.

No discussion or questions asked.

Chair Hood **motioned** to approve the Highway budget at \$350,322.00. Jennifer Hoyt **seconded** the motion and it passed unanimously.

4910 – Highway Projects – Bill McDuffie Jr. – \$170,000

No Discussion or questions asked.

Chair Hood **motioned** to approve the Highway Projects budget at \$170,000. Dave Kelly **seconded** the motion and it passed unanimously.

4130 - Executive - \$112,466

4153 - Legal- \$15,000

4155 – Personnel Adm – \$14,641.00

TA Rollins gave a brief explanation of the increase, stating that a lot of the increase were for items out of their control. She is still awaiting final figures on payroll taxes.

Chair Hood **motioned** to table the vote on Personnel Adm budget. David Merwin seconded the motion which passed unanimously.

4194 – General Government Buildings - \$67,888

No discussion or questions asked.

Chair Hood **motioned** to accept the General Government Buildings budget at \$67,888. Bill McDuffie Sr. **seconded** the motion which passed unanimously.

4196 – Insurance – \$20,336

No discussion or questions asked.

Chair Hood **motioned** to approve the Insurance budget at \$20,336. Jennifer Hoyt **seconded** the motion which passed unanimously.

4197 – Advertising and Association Dues - \$5,500.00

Brief discussion occurred on this item regarding Public Hearing notices. Chair Hood **motioned** to accept the Advertising and Association Dues budget at \$5,500.00. Selectman Walker **seconded** the motion and it passed unanimously.

4199 – Other General Gov't. – \$1,000.00

No discussion or questions asked.

Chair Hood **motioned** to approve the Other General Gov't. budget at \$1,000.00. David Kelly **seconded** the motion which passed unanimously.

4316 – Utilities & Street Lights - BoS – \$3,200.00

No discussion or questions asked.

Chair Hood **motioned** to approve the Utilities and Street Light budget at \$3,200. David Kelly **seconded** the motion which passed unanimously.

4323/4324 – Recycling/Transfer Station

Selectmen Walker requested that they table these items until the next meeting as they are still working on the numbers.

Chair Hood inquired as to the status of the generator. Selectman Walker said that they are currently working on delivery dates. They expect it by January. Marcia Murphy inquired as to the increase in the Transfer Station Manager's salary. Selectman Walker said that the increase is a reflection of the actual work that this role is responsible for.

Marcia Murphy also wanted to know if Mr. LaFlamme will be taking a more active role in budgeting. Selectman Walker said that is something they will be working with him on.

Marcia Murphy asked if they expect the budget to decrease with the new compactor in place. Selectman Walker responded that they do expect a decrease.

Chair Hood **motioned** that they table the Recycling budget to review at a future meeting. David Kelly **seconded** the motion which passed unanimously.

Chair Hood **motioned** that they table the Transfer Station budget to review at the next meeting. Selectman Walker **seconded** the motion which passed unanimously.

4325 – Solid Waste Clean-up - \$9,600

No discussion or questions asked.

Chair Hood **motioned** that they accept the Solid Waste Cleanup Budget at \$9,600. David Merwin **seconded** the motion which passed unanimously.

4414 – Animal Control - \$1.00

No discussion or questions asked.

Chair Hood motioned that they accept the budget for Animal Control at \$1.00. Selectman Walker seconded the motion which passed unanimously.

4415 – Health Agencies - \$2,500

Chair Hood reviewed a request to include money in their budget to support CASA (Court Appointed Special Advocates)

Chair Hood **motioned** that they accept the budget for Health Agencies at \$2,500. David Kelly **seconded** the motion which passed unanimously.

4442 -Direct Assistance – \$22,000

Chair Hood asked why this budget doesn't seem to get spent. TA Rollins explained that it depends on what assistance is needed by residents.

Chair Hood **motioned** that they accept the budget for Direct Assistance at \$22,000 David Merwin **seconded** the motion which passed unanimously.

4583 - Patriotic Observations – \$4,160

Chair Hood noted that the increase of \$160 is to purchase more flags. Chair Hood **motioned** to accept the budget for Patriotic Observations at \$4,160. David Kelly **seconded** the motion which passed unanimously.

4711 - Debt Services – Principal - \$50,246

No discussion or questions asked.

Chair Hood **motioned** to accept the budget for Debt Services- Principal at \$50,246 Selectman Walker **seconded** the motion which passed unanimously.

4721 - Debt Services – Interest - \$2,913

No discussion or questions asked.

Chair Hood **motioned** to accept the budget for Debt Services- Interest at \$2,913 Selectman Walker **seconded** the motion which passed unanimously.

4723 – Interest – TANS

4919 – Agency Funds (CC Town Contribution) - \$0.00

Chair Hood **motioned** to accept the budget for Agency Funds at \$0.00 David Merwin **seconded** the motion which passed unanimously.

5400 – Transfers to Trust Funds - \$0.00

No discussion or questions asked.

Chair Hood motioned to accept the budget for Agency Funds at \$0.00 Selectman Walker seconded the motion which passed unanimously.

5500 – CRF

Discussion occurred regarding future plans for developing a highway department, and what the scope of the project might be. Marcia Murphy asked for particulars on anticipated staffing and equipment needs for such a department: would they go with an Elected Road Agent with town employees that work under them, or a different arrangement? Selectman Walker said they haven't looked deeply into it at this point but acknowledges that it is something they need to begin working on, perhaps beginning with developing a committee.

Selectman Walker suggested leaving the CRF Warrant Articles level funded at \$113,500 for this year, adding \$8,500 to the Equipment line.

Discussion also occurred regarding the possibility of developing a Public Works department.

TA Rollins said that the estimated Meals and Rooms tax has been added to the revenue sheet.

OTHER BUSINESS

BoS update: Selectman Walker gave an update from the Board of Selectmen:

- The tax rate was set at \$23.75 (down from \$24.60 last year).
- The generator for the Transfer Station has been delivered, and they are hopeful that they will be seeing the compactor by the end of this year.

Chair Hood stated that the next meeting will be held on December 13 at 7 p.m.

Chair Hood **motioned** to adjourn the meeting. Bill MacDuffie Sr. **seconded** the motion and the meeting adjourned at 8:09 p.m.
