# Adjustments to Building Codes

The Board reviewed a request to:

- Remove Article VII from the Building Codes
- Create a new private camping ordinance (New Article XXII in A.O.)
- Increase the Camping Permit Application Fee and increase the Building Permit Fees in the Building Codes.

David Hostetler asked what brought about this request. Chair Schmidl recalled a situation in which someone that camped long-term on their property created a bit of a problem. Loretta Razin noted other current camping situations in town and wondered if that is what led to this request.

Some Board members felt that the suggested private camping ordinance was too restrictive. After some discussion regarding the request, the Board decided that they would study the matter further and bring their input, concerns and suggestions to the next meeting, noting they should also check and see how other towns are handling this.

They would also like the Selectboard to provide some guidance identifying what sorts of problems they are looking to avoid so that they can be sufficiently rigorous in their development and also if there is a timeline for completion.

# Public Hearing Notice

The Public Hearing for the proposed Boscawen subdivision will be held on Wednesday July 5, 2023 at 6:30 p.m. All Board members are welcome to attend. Brief discussion took place to review any concerns that should be voiced at this hearing. They will express Fire Chief MacDuffie's concerns regarding the increase in homes so close to the town line and their lack of resources/volunteers to handle that increase.
