**Open Meeting:** Chairman April Rollins opened the meeting at 9:03 am.

**Meeting Minutes:** Member Kathleen Doyle made a **motion** to approve the minutes of October 13, 2020. Member Mike Broas **seconded**; the **motion passed** with all in favor.

**Fireworks and donation of remaining funds:** Annual fireworks display will be held at Maplewood Ball Field on September 11<sup>th</sup>, at dusk. Kathleen Doyle will organize a flag football game for the kids before the fireworks. Nancy Hayden is organizing the fund raising for the annual fireworks display. April explained that all donations for the fireworks need to be accepted by the Selectmen and will be noted in the Board of Selectmen meeting minutes. A discussion took place about accepting those donations into the Recreation Revolving fund and paying for the annual FW display out of that fund. All donations from now until September would go into the fund and any money remaining after the display was paid for would remain in the Recreation fund. Member Doyle asked if Nancy Hayden would become a member of the Recreation Committee? April responded that the Rec. committee is a 5-member committee and there are no vacancies at this time. Kathleen Doyle thinks it is a 7-member committee. April is sure it is a 5-member committee and the change to a 7-member would require a warrant article vote at Town Meeting. April agreed to verify this information. Chairman Rollins made a **motion** for the Recreation Committee to sponsor the annual fireworks and accept the donations into Recreation Revolving Fund. Vice Chair Dave Kelly **seconded**; **motion passed** with all in favor.

**Old Home Day Co-ed Softball game:** Kathleen will organize the teams; Dave and Jocelyn will be available to help. April may not be available that day.

**Playground Equipment and Bleachers- LWCF Grant Update:** The playground construction is almost complete. April Rollins has organized several volunteers to complete the assembly today. April is also working on the spreadsheet to submit for the grant reimbursement.

**Other Business:** April confirmed the donation of \$1500 from Joan Young has been accepted into the Recreation Revolving fund. This money will be used to construct a batting cage in the spring of 2022. The cage has not been ordered yet. Kathleen Doyle will order the netting for the cage and the pipes will be purchased locally.

**Adjournment:** Kathleen Doyle made a **motion** to adjourn, **seconded** by Dave Kelly, **motion passed** with all in favor. Meeting adjourned at 9:15 AM.
